

Conditions of entry

1. The competition will be swum under A.S.A. Laws and Technical rules and licensed by the ASA for entry into National Competitions.
2. Age groups are: 10/11, 12/13, 14/15, and 16+ years and open for Girls 800m and Boys 1500m events. The 50m swims are G12-15, G16+ & B12-15, B16+. Ages on 22nd Apr 2012 .[last day of the meet]
3. All events will be run on a heat declared winner (HDW) basis. The last heat in each event will be spearheaded. **25m entry times should be submitted.**
4. All entries are subject to meeting the qualifying times. Entries may be restricted in order to keep the session times within appropriate time scales – slowest times within each age group will be rejected.
5. **No Time Trials will be held.** Any empty lanes after sign in may be filled by Crawley swimmers. If space permits swimmers just outside the entry times will be accepted.
6. All swimmers in the 400m, 800 & 1500m events will need to sign in before the warm up. All other events the **Active withdrawal** system will operate. Forms will be available poolside and on the desk. Withdrawals must be made before the start of the session warm up. Withdrawals can be emailed in advance.
7. Awards will be given in the above age groups placed 1st to 3rd without disqualification for 100,200,400 events. 50m swims & 800 & 1500 are u15 & 16+. These awards can be collected from the awards table poolside.
8. Entry fee is £5 for 50m, £6 for 100m and 200m for 400m events £8 for the 800m and 1500m events. Entries will be via email on the Hy-tek software available from the Crawley website. Entries must be sent by club with a single club cheque, £5 surcharge for individual non Hytek entries. Coach passes are £20 which will entitle the holder to admission to all sessions, a program and poolside refreshments (not food). Passes must be displayed at all times.
9. All meet participants and spectators must observe all safety precautions in operation at K2 Crawley Leisure Centre and follow the instructions of pool staff.
10. Swimmers must not go up to the balcony without first drying off and putting on footwear and clothing before leaving the poolside.
11. Competitors are advised not to leave their belongings unattended and to ensure that all valuables are placed in a locked locker (a returnable £1 coin). Neither Crawley Swimming club nor K2 Crawley Leisure Centre can accept responsibility for any property that may be lost or stolen.
12. Video recording /Photography / Mobile phones. In accordance with the recommendations of the ASA child protection policy, any person wishing to use video, zoom or close range photography, including mobile phones that have photographic capabilities should first register their details at the spectator entrance. It is requested that all mobile phones are switched off or to silent during the competition and that there is no flash photography at the start of each event.
13. Data protection with the submission of entries. Consent is deemed to have been given, as required of the data protection act, to the holding and distribution as necessary, of personal information on computer, to run the meet.
14. The promoters reserve the right to alter the schedule if circumstances demand and if necessary restrict entries. **Swimmers only accepted in the 50m swims due to oversubscription will not be offered refunds for these events if they choose not to attend.**
15. Closing Date for entries to be received is **Friday 30th March (midnight).**
