Promoters Conditions (v2 29.12.25)

At a glance:

This is a Level 1, Long Course competition. The competition will be swum under Swim England Laws and Technical rules and licensed by Swim England. The Meet Promoter is Crawley Swimming Club and the meet will be overseen by an appointed Meet Manager and Referee.

Venue: K2 Leisure Centre, Pease Pottage Hill, Crawley RH11 9BQ.

Pool: 50m, 8 Lanes with anti-turbulence lane ropes.
Electronic timing with touch pads at both ends.
Backstroke Ledges available
Secondary Strobe light available – Swimmers requiring this are requested to declare this with their entry.

Events: 50m, 100m, 200m all strokes
200m, 400 IM,
400m Freestyle
800m, 1500m Freestyle – **These events are for swimmers aged 11+ only**

Age Groups: 10-11yrs, 12yrs, 13yrs, 14yrs, 15yrs, 16+yrs
Age as of 31st December 2026

Qualifying Times: Lower qualifying times apply – all times must be equal to or faster than these.
All entry times should be converted to Long Course times.

Awards: Top 3 in each category will receive awards

Entry Fees: £9.50 per 50m, 100m, 200m
£10.50 per 400m
£15.00 per 800m/1500m

Coach Pass: £10 per day

Spectator Entry: £5.50 per session/£13 all day. Children under 12yrs - Free

Entries Open: Friday 27th February @ 7:00am
Closing Date: Friday 13th March @ 8:00pm



Eligibility for entry:

1. All swimmers must be aged 10 years or over at 31st December 2026. Only swimmers aged 11+ are eligible to enter the 800m & 1500m Freestyle events.
2. Swimmers must be registered with Swim England as competitive swimmers with 'Club Compete' Membership.
3. Overseas competitors may be accepted to compete under an Overseas Registration at the Promoter's Discretion. They must provide documentary evidence of their registration with a Swimming Club and entry times. This evidence must be provided to the Meet Promoter before the Meet closing date.
4. Competitors are either Open/Male or Female. Female category is for birth sex females in accordance with Swim England's Transgender and Non-Binary Competition Policy. By entering the 'Female' category, a swimmer confirms that their birth sex is Female.
5. Lower limit qualifying times apply. All entry times must be equal to or faster than these. Short Course time conversions can be used.
6. Submitted entry times must be verified on Rankings and must have been achieved at a licenced meet or an International equivalent since 1st January 2025. Random checks on entry times will be made. If a swimmer is found to have entered with false times, they may be disqualified from all events they have entered, and their entry fees will be forfeited.
7. Para swimmers are exempt from qualifying times but please advise when submitting entries so that their entries are not rejected if outside of qualifying times. Also include if any special arrangements are required (i.e. strobe, outside lane).

Submitting Entries:

8. Club Entries should be made by Hy-Tek Meet Manager software. The HyTek Entry File is available on our Website or by emailing openmeets@crawleysc.co.uk to request it.
9. Individuals/Clubs can download TM Lite from Hy-Tek [here](#) for free and use the Hytek Entry File available on our Website in order to submit their entries by email to openmeets@crawleysc.co.uk.
10. Individual entries can also be made via swim-meet (link provided on our website).
11. Individual entries will incur a £10 administration fee, per swimmer.
12. Please note that Swim England Rankings may reject Meet results containing database errors. The errors are often in the accuracy of the entrant's name, the official club's name and entrant's date of birth. As recommended by the Rankings Department, all entries will be validated using the online entry tools available at www.swimmingresults.org. It is therefore recommended that Clubs should use these tools to validate their entries prior to submission. Entries that are found to contain errors may be rejected. Re-submitted entries will be deemed to have arrived at the time of re-submission.

Individual Swimmers:

13. Individual swimmers under the age of 16 years must have a responsible adult in the facility at all times when they are present. The parent/guardian is responsible for arranging suitable supervision of their swimmer. If the parent/guardian is not eligible to download a Swim England Accreditation the swimmer should remain with the parent/guardian in the spectator gallery when not competing. If the parent/guardian is able to download a Swim England Accreditation, they may apply/purchase a Poolside pass to supervise their swimmer on poolside.

Entries Acceptance:

14. Entries will be accepted on a 'Fastest to slowest time' basis. Improved times will not be accepted after the entries have been received.
15. If the Meet is oversubscribed the Promoter shall remove the slowest swimmers from each age group per event until the accepted number of swims fit in the available time for each session or to keep within the venue capacity.
16. The Promoter reserves the right to move events to another Session (as a last resort) if a session is oversubscribed and in doing so would allow more entries to be accepted. In this circumstance clubs will be notified and given 48 hours to withdraw (without charge) any swimmers impacted by this change. After 48 hours entries will be confirmed and invoiced.
17. The Promoter reserves the right to accept late entries and entries outside of the qualifying times if the meet is undersubscribed.
18. Heats will be swum with all eligible age groups combined and swimmers will be seeded using submitted entry times to spearhead heats. Winners will be decided on a heat declared winner (HDW) basis.
19. The Mixed 1500m Freestyle may be restricted to 3 heats (12 Female & 12 Open/Male).
The Mixed 800m Freestyle may be restricted to 4 heats (16 Female & 16 Open/Male)
The 400m Freestyle events may be restricted to 4 heats.
The 400m IM events may be restricted to 4 heats.

Sign In & Marshalling:

20. Swimmers competing in the 800m/1500m events must sign in before the start of Warm up for that session. Failure to sign in on time may result in their entry being withdrawn to allow a swimmer on the waiting list to compete.
21. Swimmers must report to marshalling when they are called. Any swimmer who fails to report to the Marshalls in time may be withdrawn from that event. Racing will not be delayed due to swimmers not reporting on time.

Withdrawals:

22. An online withdrawal system will be in operation. Club specific QR codes will be sent to clubs at least one week before the gala. The QR code needs to be scanned on a smart phone, which links to a withdrawal sheet that is sent automatically to the Meet Management Team.
23. Withdrawals must be made no later than 10 minutes after the start of the first warm-up for each session.

Rejections & Reserve List:

24. Accepted and rejected entries will be available on our Website no later than 1 week after the closing date. It is the competing club/swimmer's responsibility to check this list for accuracy and advise the Meet Promoter within 24 hours of any errors. Please note that if the letters '**SCR**' appear next to your entry time, this indicates that your entry has been rejected in accordance with these conditions.
25. In the event that the meet is oversubscribed, a reserve list will operate. Swimmers whose entries are initially rejected have 5 days from the publishing of the confirmed entries to apply for inclusion on the reserve list. This can be done via a link on our website.

26. Priority will be given to swimmers on the reserve list on a first come, first served basis if/when a place becomes available. Entrants will be contacted and sent a payment link. Acceptance to the event will only be confirmed once payment is received. If payment is not received within 24 hours, the place will be offered to the next in line.
27. Spaces as a result of withdrawals received up until 8pm on 1st April will be offered to swimmers on the reserve list. Spaces available after this time will be filled with applicants for Time Trials.

Time Trials:

28. Time Trials may be accepted (for swimmers already attending the meet) at the Promoter's discretion where there is space in a heat (additional heats may be added if time within the session allows). Time Trial swims will have 'EXH' (Exhibition) appended to their name in the results. There will be a charge per entry which must be paid at the time of entry. Swimmers entering as a Time Trial will not be eligible for awards; however their achieved times will be submitted to rankings.
29. If you wish to enter as a Time Trial these can be requested at the computer desk by the start of warm up for each session.

Results & Awards:

30. The Meet Programme including results will be available on the Meet Mobile smartphone app (charges may apply). You are reminded that times on the scoreboard are not official and should be used as a guide only. Results are not official until authorised by the Referee.
31. Results will be displayed in the venue near the medals desk for swimmers to check. An Electronic copy (Hy-Tek file) of the results will be emailed to clubs after the meet. Results will be uploaded to Swim England for inclusion on Rankings.
32. Medals will be given to Female and Open/Male swimmers who have placed 1st, 2nd & 3rd in each age group. Medals should be collected at the medals desk. Uncollected medals will not be posted.

Payments & Refunds:

33. Once entries are accepted, a list of confirmed entries and an invoice will be sent. Payments should be made to: Crawley Swimming Club, A/C No 9872 8600, Sort Code 09-01-55. Reference: 'SPRING/CLUB' or in the case of an Individual entry 'SPRING/SURNAME'.
34. Payments must not be made before the invoice has been issued. If payment is not received by the date specified on the invoice, the promoter reserves the right to reject the entries in full.
35. There will be no refund of entry fees for swimmers who withdraw after the closing date, unless the withdrawal is for medical reasons supported by a doctor's certificate or medical evidence. Refunds for medical withdrawals will only be considered if the withdrawal is made before 8pm on Friday 3rd April and the appropriate medical evidence is emailed to openmeets@crawleysc.co.uk by 8pm on Friday 10th April.

Coaches & Team Managers:

36. Coaches, Team Managers and Chaperones must obtain and bring with them a printed Poolside Accreditation which can be obtained here:

Anyone unable to print their accreditation can email it to openmeets@crawleysc.co.uk at least 24 hours before the start of the gala and will be able to collect it from the entry point.



37. Poolside accreditation must be displayed at all times. Coaches and Team Managers without a valid Poolside Accreditation will not be permitted in the changing area or poolside.
38. A Poolside Pass (coaches and TM's) is £10 per day, which will entitle the holder to admission to all sessions that day, Heat Sheets and poolside refreshments (it does not include lunch). Poolside Passes are transferable, however, each person using the pass must have the relevant Accreditation.
39. Poolside Passes must be requested no later than 48 hours after the confirmed entries are published. Clubs who do not specify the number of passes they require will be invoiced for the minimum number of passes recommended by Swim England to ensure adequate supervision ratios of their swimmers.
40. All Clubs must ensure they have adequate supervision cover in line with Swim England guidelines. Details are available [here](#)

Officials:

41. All clubs submitting entries are requested to assist in the running of the meet by providing as many Licensed Officials as possible, to cover all sessions. Officials can sign up here: [Swim-Meet](#)
42. Where possible, we will offer mentoring for trainee officials. This can be requested via our Officials coordinator at: officials@crawleysc.co.uk
43. If we do not have enough officials to meet the licensing requirements, the meet could be downgraded to a lower level, and times recorded would reflect the reduced license level on rankings. No refunds will be considered in these circumstances.

Health & Safety:

44. All teams must have a Coach/Team Manager with them to access Poolside seating.
45. Swimmers must dry themselves and put on appropriate clothing and footwear before leaving the changing rooms to enter other parts of the leisure centre.
46. Competitors are advised not to leave their belongings unattended and to ensure that all valuables are placed in a locked locker (a returnable £1 coin/trolley token is required). We will be restricting the size of bags taken poolside at this event. Only a small drawstring type bag will be permitted. Oversized bags will be removed and must be placed in lockers. Neither Crawley Swimming Club nor K2 Crawley Leisure Centre can accept responsibility for any property that may be lost or stolen.
47. All phones and camera devices must stay inside bags and remain unused within the changing room area. Wavepower's Safeguarding in Changing Rooms policy prohibits all use of mobile phones or any other recording device in a changing area during Swim England regulated activity. Anyone not adhering to this requirement may be asked to leave the premises without a refund.

48. Everyone attending the competition are advised to take reasonable care when taking photographs/videos and are requested to focus on their own children as much as reasonably possible. Personal photographs/videos should avoid including other children, particularly if those images are being shared with family and friends or through social media platforms.

Spectators:

49. The Meet Programme including results will be available on Meet Mobile. You are reminded that times on the scoreboard are not official and should be used as a guide only. Results are not official until authorised by the Referee.
50. Spectator entry can be purchased in advance via Order Whizz (link on our website) or on the door. Children 12yrs and under are admitted free.





51. All adult spectators are required to wear the designated coloured wristbands for each session. Anyone NOT wearing their wristband may be refused entry.

Conduct:

52. Swimmers, Team Managers and Coaches are expected to behave appropriately at all times. This includes treating other clubs, gala volunteers and K2 staff with respect. The Meet Management reserve the right to remove any spectators, swimmer or club personnel from the event if their behaviour is against Swim England or the Leisure Centre rules or will otherwise affect the efficient running of the meet.

53. Swimmers are liable for any damage they cause to the pool equipment, particularly the blocks and the back wedges. Stamping on the block or back wedge at the start of a race is unacceptable and any damage caused in doing so will be charged to the swimmer. The swimmer also risks being stood down from the race and for repeated occurrences, being taken out of any remaining events without refund.

Data Protection:

54. Meet entries and results will be held on computer. By entering this meet it is deemed that you have given consent to Crawley Swimming Club holding and using your personal information. Swimmer entries and results (including name, age, club, race times, disqualification codes, gender and disability classification) will be made available in the venue, on our website and electronic systems such as Meet Mobile.

Other:

55. If in the exceptional circumstances it is not possible to configure the pool for a long course competition, the competition shall run as a short course competition. In these circumstances no refunds will be given.

56. Any matters not covered by these conditions will be dealt with in accordance with the laws of the sport and at the discretion of the Meet Promoter.

57. By submitting an entry, participants are deemed to agree with these conditions.
